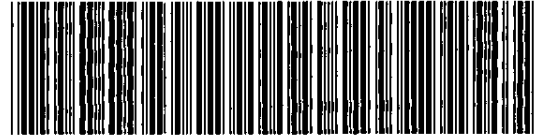

Article III- Purpose(s)

The purpose of The Pink Pumps Foundation- Single Moms Achievement Project is to assist economically disadvantaged Single Moms in obtaining financial independence, self-sufficiency eradicating them a life of poverty by teaching them financial literacy, education, investment, and business opportunities through workshops, seminars, webinars, internet and referral sources. It is also the purpose of The Pink Pumps Foundation- Single Moms Achievement Project to raise awareness in local communities as well as bring nationwide attention to the problems and struggles faced by poverty-stricken single mothers and their children.

The Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including such purposes, the making of distributions to organizations that qualify as an exempt organization under section 501 c (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, its trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purposes clause hereof. No substantial part of the activities of the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal Income Tax under section of any future tax code or (b) by an organization, contributions to which are deductible under section 170 c(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
