**ARTICLES OF INCORPORATION
OF
INSIGHT THROUGH EDUCATION, INC.**

In compliance with the requirements of F.S. Chapter 617, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a not-for-profit business corporation.

ARTICLE I - NAME

The name of the Corporation is: **INSIGHT THROUGH EDUCATION, INC.**

ARTICLE II - PRINCIPAL OFFICE

The mailing address of the principal office of the Corporation is: 101 Pembroke Drive, Palm Beach Gardens, FL 33418.

ARTICLE III - PURPOSE

This Corporation is a not-for-profit Corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. All activities and purpose of the Corporation shall be limited exclusively for any and all charitable and educational purposes, either directly or by contributions to the organization that qualify as exempt under section 501(c)(3) of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist or as they may hereinafter be amended. The purposes for which this not-for-profit Corporation is organized is to actively and financially assist, support and promote awareness and education of the Holocaust and concepts including but not limited to bigotry, freedom, prejudice and tolerance by any and all activities and means.

ARTICLE IV - MANNER OF ELECTION

All corporate powers shall be exercised by or under the authority of, and the business of the Corporation shall be managed under the direction of the Board of Directors. The number of the initial Board of Directors for the Corporation shall be as provided for in the Corporation's Bylaws. It is further provided that the number of Directors may be increased or decreased, as provided in the Corporation's Bylaws. Such Directors are to be elected or appointed in the manner proved for by the Corporation's Bylaws.




