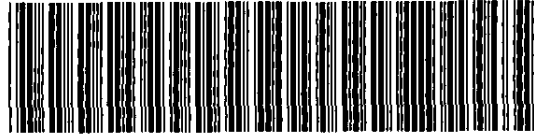

**ARTICLES OF INCORPORATION  
FOR  
THE NATIONAL SAVE THE FAMILY NOW MOVEMENT, INC.**

**ARTICLE I.**

The undersigned Incorporator is a citizen of the United States, and he desires to form a Non-Profit Corporation.

a. The name of this corporation shall be The National Save the Family Now Movement, Inc.

b. This corporation is being organized as a nonprofit corporation, pursuant to the Laws of the State of Florida as set forth in Chapter 617, Florida Statutes, and it shall have perpetual existence.

c. This corporation shall come into existence on the date the Articles of Incorporation are filed with the Department of State of the State of Florida.

**ARTICLE II. PRINCIPAL OFFICE**

The place in this State where the principal office of the Corporation is to be located is the City of Tallahassee, Leon County Florida. The principal street address and mailing address of this corporation is 1363 East Tennessee Street, Tallahassee, Florida 32308.

**ARTICLE III. PURPOSE**

The goals of The National Save the Family Now Movement, Inc., shall be to build, save and strengthen families.

a. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

b. To own, buy, sell, lease, mortgage or otherwise deal in real and personal property, and to do all things outlined by the laws of the State of Florida dealing with corporations not for profit, as now existing, or as the law may henceforth provide, as

from time to time may be necessary, or expedient in the exercise of any or all of its corporate functions, powers and rights.

c. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III herein.

d. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

e. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE IV. MANNER OF ELECTION**

Board of Directors will be appointed or elected annually at the annual board meeting, which will be held in October of each year.

b. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively

for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
