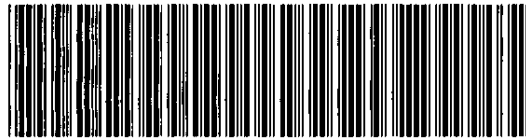

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

The purpose for which the Foundation is organized and shall be operated exclusively is to help conduct and support the activities which benefit, enhance the quality of, carry out the purposes of, to sustain, to support, to perpetuate, and to accumulate funds in perpetuity for, educational, scientific, and charitable purposes for the Safety Harbor Partners in Progress programs, within multiple divisions of municipal government organized pursuant to the laws of the State of Florida (hereinafter referred to as Safety Harbor) so long as it remains a "qualified organization."

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

Election of Directors shall be a Board of five (5). At the election, the Chairperson & Vice Chair shall be elected for a one year term; Secretary & Treasurer shall be elected for a two year term; and Board Member at Large to a three year term. The terms of the Directors shall be staggered on each year subsequent to the first election. The Director of the Safety Harbor Partners in Progress Foundation for the City of Safety Harbor shall always be a Director.
