**Article III - Purpose:** Said organization is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Said organization provides scholarships to college bound graduating seniors as chosen by the administration of Abraham Lincoln High School, Brooklyn, NY, a public high school.

**Article VIII - Dissolution:** Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or state or local government, for public purpose. All assets will be sent to Abraham Lincoln High School, Brooklyn, NY, a public high school, to provide scholarships to college bound graduating seniors as chosen by the administration of the school. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court

shall determine which are organized and operated exclusively for such purposes.
