The undersigned acting as incorporators of a corporation pursuant to Florida Corporation Statute 617, adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be:

Not withstanding any other provision of these articles, the organization shall not carry on any activities not permitted to be carried on by an organization Exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or any corresponding provision of any future Internal Revenue Law.
