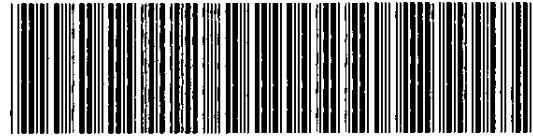

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

I. Articles of Incorporation shall be amended to include the following:

Article I – Name; Amendment of Address

The principal office and mailing address of the corporation shall be: 204 E. McKenzie St. Unit D, Punta Gorda, FL 33950 subject to change and relocation by the Officers of the Corporation.

Article VII – Registered Office and Agent

The street address of the registered office of this corporation is 204 E. McKenzie St. Unit D, Punta Gorda, FL 33950. The name of the registered agent of this corporation at that address is Dennis Postell, Jr

Article XIII - Conduct of Corporate Affairs

Section C shall be amended as follows:

C. No part of the net earnings of the corporation shall inure the benefit of or be distributable to its members, trustees, officers or other private persons, provided that nothing herein contained shall be construed to preclude any director or employee from serving the organization as an officer or in any other capacity and receiving reasonable compensation and / or reimbursement for services rendered therefore or on behalf of the Corporation. To accomplish its stated purposes this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions accordingly.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in any political campaign on behalf of any single candidate for public office with bias. The corporation may, from time to time, offer public forums to educate and encourage voters to participate in the political process in a non-partisan way in accordance with the 501 (c) (3) IRS procedures.

Article XV – Government shall be added to Articles of Incorporation


Real Life Church, Inc. shall be conducted through the form of ecclesiastical governance in accordance with Holy Scripture. The church is a Theocracy, directed by the Almighty God and Holy Scriptures (The Bible). General operations of the corporation shall be provided by the bylaws as set forth accordingly.

- A. The church shall be autonomous in all matters pertaining to business and operations with all provisions and privileges set forth as a non-profit corporation within the State of Florida and as provided under present and future IRS 501 (c) (3) Codes.
- B. Said autonomous privileges and provisions shall include but not be limited to: The acquisition either by deed, gift or purchase, any real estate or personal property to be held in trust for the benefit of the Corporation and its stated purposes;
- C. To mortgage, sell, gift or otherwise encumber any such property when such action is deemed to be in the best interests of the Church as defined in its stated purposes as a Christian organization.

II. No members are entitled to vote on said amendment(s).

III. The enclosed amendment(s) were adopted by the members of the Board of Directors of the Corporation. The date of adoption of said amendment(s) was January 16, 2011
