ARTICLES OF INCORPORATION OF ZETAS ZEAL FOUNDATION, INC.

In compliance with the requirements of the laws of the State of Florida, and for the purpose of forming a corporation not for profit pursuant to Chapter 617, Florida Statutes, the undersigned does hereby acknowledge:

ARTICLE I - NAME

The name of the corporation shall be ZETAS ZEAL FOUNDATION, INC., hereinafter referred to as the "Foundation."

ARTICLE II - PRINCIPAL OFFICE

The initial principal office is located at 2605 E. 21st Avenue, Tampa, Florida 33605. The mailing address is P. O. Box 11967, Tampa, Florida 33680-1967. The Board may, from time to time, move the principal office or change the mailing address to any other address in Florida.

ARTICLE III - PURPOSE

The Foundation is organized exclusively for charitable and educational purposes, including but not limited to, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or as amended, or corresponding provisions of any subsequent federal tax code. Specifically, the Foundation is organized to promote and enhance youth and community development, and undertake such activities as will further the general purposes described herein.

ARTICLE IV - LIMITATIONS

At all times the following shall operate as conditions restricting the operations and activities of the Foundation:

- 1. No part of the net earnings of the Foundation shall inure to the benefit of, or be distributable to, its members, directors or officers, or to any other private persons, excepting solely such reasonable compensation that the Foundation may pay for services actually rendered to the Foundation, or allowed by the Foundation as a reasonable allowance for authorized expenditures incurred on behalf of the Foundation.
- 2. No substantial part of the activities of the Foundation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and the Foundation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
- 3. Notwithstanding any other provision of these articles, the Foundation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended or by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

ARTICLE V - MANNER OF ELECTIONS OF THE DIRECTORS

The manner in which the Directors shall be elected or appointed shall be provided in the By-laws.

ARTICLE VI - INITIAL DIRECTORS

The number of persons constituting the first Board of Directors of the Foundation shall be five (5) members. The Board of Directors who shall serve until the next election at the regular annual meeting are:
