ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

Charitable Foundation For Enlargement, Preservation and/or Acquisition of Physical Assets for
Southside United Methodist Church, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

to support and benefit, solely and exclusively, the Southside United Methodist Church (SSUMC), located at 3120 Hendricks Avenue, Jacksonville, FL 32207 in the furtherance of its religious, charitable and educational functions including, but not limited to the following: 1.) to enlarge and preserve the present physical properties of SSUMC; 2.) to solicit, receive and accept conveyances, grants, gifts and donations, legacies, bequests or devises, of all kinds of property; 3.) to provide funds for the maintenance and improvement of the physical assets of the SSUMC necessary to permit the church to perform its exempt activities; 4.) to provide funds for the purchase(s) of real, personal and/or mixed property, as physical assets for the SSUMC

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The Foundation shall consist of no more than eleven trustees and no less than seven trustees. There can be three positional trustees (Senior Pastor of SSUMC; Chairman of the Trustees of SSUMC; Chairman of the Administrative Board of SSUMC). These trustees are elected by the Charge Conference of SSUMC. There can be up to three representative trustees who are nominated by the three positional trustees and elected by the Charge Conference of SSUMC. There can be five General Trustees, originally nominated by the Settlers of the Trust and elected by the Charge Conference of the SSUMC. Thereafter all successor General Trustees shall be nominated by the then serving General Trustees, and such nominee(s) shall be subject to election by the Charge Conference of the SSUMC. At all times, the General Trustees shall be less than 50% of all of the Trustees.

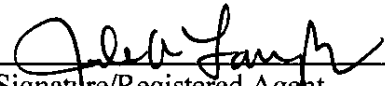
