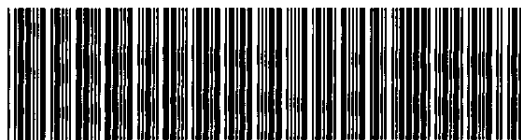

Amend Article III to read: A foundation which was formed in memory of Coralrose Eve Fullwood (November 24, 1999 - September 17, 2006). Our mission is to provide education and counselling to law enforcement and families effected by murdered or missing children while recognizing and respecting each family's unique cultural heritage.

Add Article IX: A. Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

B. Upon dissolution of the organization, all assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations,


