## AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE AMERICAN ISRAELI BAR ASSOCIATION A FLORIDA NOT-FOR-PROFIT CORPORATION

In accordance with the provisions of Florida Statutes Sections 617.1002 and 617.1006, THE AMERICAN ISRAELI BAR ASSOCIATION., a Florida corporation (the "Corporation"), hereby amends its Articles of Incorporation filed on September 20, 2010, as follows:

1. Add Article XIV as follows:

## ARTICLE XIV DISTRIBUTION OF ASSETS

Upon dissolution of this corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of this corporation, dispose of all of the assets of this corporation exclusively for the purposes of this corporation in such manner, or to such organization or organizations organized and operated exclusively for similar purposes as described in Article V hereof, and that shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provisions of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of this corporation is then located, exclusively for such purposes or to such organization or organizations, as such court shall determine, which are organized and operated exclusively for such purposes. No assets of this corporation shall be distributed to any officer, Director or member of this corporation.

- 2. The Amendment shall be adopted effective as of the date filed.
- 3. The Amendment was adopted by all Officers and Directors of the Corporation.
