ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S. (Not for Profit)

The undersigned subscriber to the Articles of Incorporation and to this First Amendment to the Articles of Incorporation, is a natural person, competent to contract, and hereby amends the Articles of Incorporation of the NICKI WILLMAN MEMORIAL FUND, INC., A Corporation Not for Profit, under the Laws of the State of Florida as follows:

<u>ARTICLE VIII - CHARITABLE EXEMPTION</u>

- A. Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- B. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

In All Other Respects, the seven (7) Articles of Incorporation of the NICKI WILLMAN MEMORIAL FUND, INC. filed September 8, 2010 with the Florida Department of State Division of Corporations bearing Document # W10000042349 are ratified and confirmed as stated.
