# Article III Purpose - Attachment One

This not-for-profit corporation is established to reach out to people in a holistic manner. It will teach communities how they can achieve spiritual renewal and personal growth, through evangelistically formed outreaches. It will teach leaders of churches how they can expand their spiritual and social programs, through conducting conferences and seminars. It will provide philanthropic, humane, and public health services to orphans, widows, and the disenfranchised, through financial sponsorship, food and clothing distributions, and health awareness conferences.

This not-for-profit Corporation is organized exclusively for religious, charitable, scientific, literary, and educational purposes, within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1986 or the successor provision of any United States Internal Revenue law, including for such purposes, the making of distributions to organizations that qualify under section 501(c)(3) of the Internal Revenue Code, or any corresponding section of any future federal tax code. To the end that the foregoing objectives and purposes and accomplished, this not-for-profit Corporation shall have the power to engage only in such activities as shall not constitute business unrelated to its religious, benevolent, charitable, literary, and educational purposes. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of Internal Revenue Code of 1986 or the successor provision of any United States Internal Revenue law.

The Corporation may receive and administer funds for religious, charitable, scientific, literary, and educational purposes, within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1986.

No proceeds of the not-for-profit Corporation will enrich any individual, except that reasonable compensation may be paid for services to the not-for-profit Corporation.

If the not-for-profit Corporation dissolved, after providing for the payment of its debts and obligations, the remaining assets will be distributed to Redemption World Outreach Center of Greenville, South Carolina serving a similar purpose and qualifying as a tax-exempt, charitable organization under the provisions of 501(c) (3) of the Internal Revenue Code.
