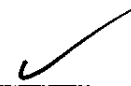

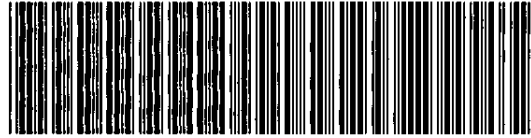

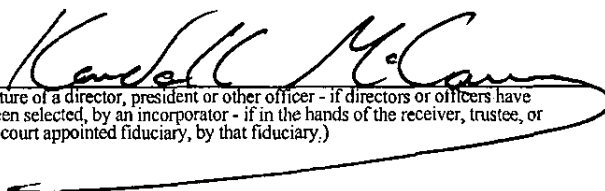

Purposed Clause and Dissolution of Assets Provision

Purposed Clause:

Our Purpose: To financially equip the next generation of young leaders passionate about impacting a lost world with the Gospel of Jesus Christ and sharing His love through international and domestic mission projects.

Dissolution of Assets Provision:

Upon the dissolution of the corporation (Destination Global Ministries, Inc.), assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code. Any assets not so disposed shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is located. Disposal shall be made exclusively for exempt or public purposes, or be made to such organization or organizations as the court shall determine to be organized exclusively for such purposes.
