ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit) 2010 SEP 23 PM 4: 27

The undersigned, for the purpose of forming a corporation under the nonprofit laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

Heroes in the Real World, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal street address and mailing address, if different is:

8056 SW 22nd CT., Davie, FL. 33324

ARTICLE III PURPOSE

The purposes for which the corporation is organized are as follows:

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Heroes in the Real World, Inc. will accomplish this through the production of educational and informational television, Internet, and related media presentation documentaries and support materials, aimed at bringing about awareness of sustained humanitarian efforts around the world.

Heroes in the Real World, Inc. may therefore seek, apply for, and receive donations, grants, loans, and other funding from individuals, organizations, corporations, government agencies, and others to help support the furtherance of these charitable, scientific, and educational purposes through its own continued operation.

Notwithstanding any other provision in its By-Laws, Heroes in the Real World, Inc. shall not carry on any other activities not permitted to be carried on by: (a) a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law); (b) a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law); or (c) a corporation under the Florida Not-for-profit Corporations Act (Chapter 617, F.S.).

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

Board members will elect Directors at the annual corporate meeting by a two-thirds vote. Should a candidate not receive a majority vote, a new director candidate will be considered for that position and voted upon. This course will continue until the position is filled or until the position can be legally eliminated. The initial startup Board of Directors will contain the minimum three directors required by Florida law plus one additional Director.
