

ARTICLES OF INCORPORATION SECRETARIE OF STATE DOVES Fly 360, Inc., a non-profit corporation

Article 1- The name of the nonprofit corporation is Doves Fly 360, Inc.

Article II - The principal office for Doves Fly 360, Inc., is 319 SW 3rd Avenue, Gainesville, Florida 32601.

Article III - The purpose of Doves Fly 360, Inc., is to provide the profits from the sales of tee-shirts and other garments, designated by Dragonfly Graphics as Doves Fly 360, Inc., designs and products, to the public, either through other charitable organizations or directly through Doves Fly 360, Inc., to organizations, including international, national, community based, and to individuals in need during crisis, or to facilitate funds for food, shelter and any other necessary provisions to groups or individuals that are in need or suffering.

It is the mission of Doves Fly 360, Inc., to provide nonpartisan charitable assistance in the promotion of international and local peace and tolerance; and through donations to organizations that Doves Fly 360, Inc., determines promote peace, tolerance, help to the poor, in need, homeless and victims of war, and natural disasters on a international, national or local level.

Doves Fly 360, Inc. shall comply with all record keeping provisions pursuant to the Internal Revenue Service, as a nonprofit public charity corporation; including separate records which document all profits from the sale of Doves Fly 360, Inc.'s products, after all costs, including but not limited to: purchase of materials, production, shipping and mailing, employee compensation, advertising and marketing, and filing and copying costs of Doves Fly 360, Inc.

Doves Fly 360, Inc. shall keep records detailing all activities, financial and non-financial. Articles of Incorporation; Annual Reports, including required schedules; Exemption Applications and Returns; Unrelated Business Income Tax filings and forms shall be located at the principal place of business of Doves Fly 360, Inc. All records shall be available for public inspection during regular business hours at the principal place of business, 319 SW 3rd Avenue, Gainesville, Florida, 32601.
