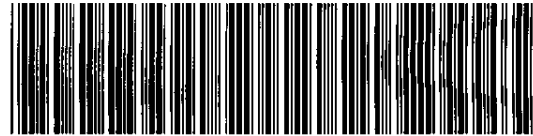

ARTICLES OF INCORPORATION
OF
MAUDY BROWN WORLDWIDE EVANGELISTIC MINISTRIES, INC.

The undersigned being desirous of forming a corporation under the provision of Chapter 617 of the Florida Statutes do agree to the following:

ARTICLE I

The name of this corporation is: MAUDY BROWN WORLDWIDE EVANGELISTIC MINISTRIES, INC., and its principal office is located at 1445 North West 6th Avenue, Fort Lauderdale, FL 33311.

ARTICLE II

This corporation shall have perpetual existence unless dissolved pursuant to law. Its existence shall commence upon filing with the Secretary of State.

ARTICLE III

Notwithstanding any other provision of these articles the purpose for which the corporation is organized are exclusively charitable, scientific, literary, and educational, with the meaning of Section 501(c)(3) of the Internal Revenue Code.
