

ARTICLES OF AMENDMENT

ARTICLES OF INCORPORATION OF

SEMINOLE CLUB OF NAPLES, INC., a Florida corporation

FIRST:

The date of filing of the Corporation's Articles of Incorporation was September

28, 2010.

SECOND:

The following amendment to the Articles of Incorporation adding the below Article XII was adopted by Board of Director vote held on May 1, 2012, in which the votes were unanimous and sufficient for approval. The amendment is intended to be effective September 28, 2010.

ARTICLE XII: 501(c)(3) EXEMPTION

The Corporation is organized solely for charitable, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to the state or local government for a public purpose. Any such assets not disposed of shall be disposed of by a Court of competent jurisdiction in the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
