ARTICLES OF INCORPORATION

OF

The undersigned natural person, competent to contract and acting as incorporator & a corporation not for profit under Chapter 617 of the Florida Statutes, adopts the following articles of incorporation.

ARTICLE I - NAME

The name of this corporation is TALLAHASSEE ASSOCIATION OF WEDDING PROFESSIONALS, INC. and the principal office address is:

ARTICLE II – PURPOSES
