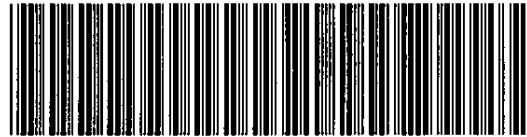

The undersigned natural person, competent to contract and acting as incorporator ⁵⁸a corporation not for profit under Chapter 617 of the Florida Statutes, adopts the following articles of incorporation.

ARTICLE I - NAME

The name of this corporation is TALLAHASSEE ASSOCIATION OF WEDDING PROFESSIONALS, INC. and the principal office address is:

565 Hickory Street
Monticello, FL 32344

ARTICLE II - PURPOSES

The purpose for which this Corporation is organized is to foster the interest of its members in their provision of goods and services for weddings. It is intended that the Corporation qualify as a business league pursuant to Section 501(c)(6) of the Internal Revenue Code.

ARTICLE III - MEMBERS

This Corporation may have more than one class of members as defined and described in its Bylaws. The Bylaws shall further provide for the respective rights and obligations of each class of members. No profit or net earnings of the Corporation shall inure to the benefit of any member.

ARTICLE IV – CORPORATE POWERS

The exercise of corporate powers of the corporation shall be vested in its board of directors, except as provided by these Articles of Incorporation, the Bylaws of the corporation and law.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The initial registered agent and the initial registered office of the Corporation are:

ARTICLE VI - INCORPORATORS

ARTICLE VII - DIRECTORS

The Bylaws shall specify the number of directors, which shall be not less than three (3) and no more than seven (7). The initial directors shall be Linda Long, Edna Hall, Lewis Johnson, Karynn Gross, Robin Adams, Hayley Mann and Kathy Armstrong-Carlson. The manner in which the directors are elected is stated in the Bylaws.

ARTICLE VIII – OFFICERS

The affairs of the corporation are to be managed by officers designated in the Bylaws and whose duties and responsibilities shall be described in the Bylaws. Officers will be elected annually in the manner set forth in the Bylaws.

ARTICLE IX - BYLAWS

The Bylaws may be adopted by the first board of directors. Thereafter, the Bylaws shall be amended by the members in the manner set forth in the Bylaws.

ARTICLE X - POWERS OF CORPORATION

To promote and protect the interests of the members, the Corporation may undertake such activities and exercise such powers as are permitted under Florida law.

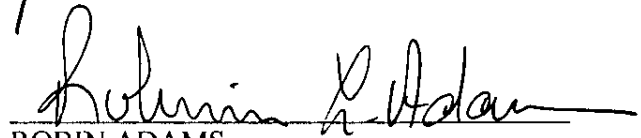
ARTICLE XI - DISSOLUTION
