# **Articles of Incorporation**

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Laws of The State of Florida Chapter 617 of the Florida Statutes (F.S.), do hereby certify:

#### Article I - NAME

The name of the Corporation shall be GIGPHARM LAB INC.

#### **Article II - PRINCIPAL OFFICE**

The address of the principal office of this Corporation is 15310 Amberly Drive Suite 250, Tampa, Florida 33647 and the mailing address is the same.

#### **Article III - PURPOSE**

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
