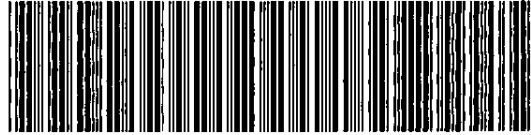

ARTICLE IX

a. 
