

OF

Article I

Name

The name of the corporation shall be: Hope Bridge Residential Center, Inc.

Article II

Article III

Purpose

The Hope Bridge Residential Center, Inc. is organized exclusively for charitable and educational purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Hope Bridge Residential Center, Inc. is a not-for-profit corporation organized under the laws of the state of Florida. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its directors or officers, except to the extent permissible under the Articles of Incorporation and Bylaws, under law and under 26 U.S.C.A. § 501(c)(3) of the Internal Revenue Code. No private individuals shall have any vested right, interest or privilege in or to the assets, income, or property of the Corporation and no part of the income or assets of the Corporation shall be distributable to or for the benefit of private individuals, except to the extent permissible under the Articles of Incorporation and Bylaws, under Florida law, and under 26 U.S.C.A. § 501(c)(3) of the Internal Revenue Code.
