#### **ARTICLES OF INCORPORATION OF**

# O.A.K. MINISTRY, INC.

WE, the undersigned incorporators, being natural persons competent to contract, hereby subscribe to these articles to form a non-profit corporation under and pursuant to the laws of the State of Florida, for the purposes hereinafter stated:

#### ARTICLE I - NAME

The name of this non-profit corporation shall be O.A.K. Ministry, Inc.

#### ARTICLE VII - COMPLIANCE

#### Section One

Said corporation is organized exclusively for charitable, education, and religious purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code (or corresponding section of any future Federal tax code).

# Section Two

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set for in Article III hereof. No part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c) (3) of the Internal Revenue Code (or corresponding section of any future Federal tax code).

#### Section Three

Upon dissolutions of this corporation assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code; i.e., charitable, education, or religious (or corresponding section of any future Federal tax code). The first choice for such distribution is The Church of the Holy Child, Ormond Beach, FL.

# Section Four

However, if the named recipient is not then in existence or no longer a qualified distributee, or unwilling or unable to accept the distribution, then the assets of this corporation shall be distributed to a fund, foundation or corporation, organized and operated exclusively for the purposed specified in Section 501(c) (3) of the Internal Revenue Code (or corresponding section of any future Federal tax code).
