ARTICLES OF AMENDMENT to ARTICLES OF INCORPORATION of MUSIC FOR THE HEART FOUNDATION, INC

Pursuant to the provision of Chapter 617, Florida Statutes, the Undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: Article I is amended and the name of the corporation is

MUSIC FOR YOUR HEART FOUNDATION, INC.

SECOND: Article III is amended so that the purpose of the corporation is:

AN ORGANIZATION DEDICATED TO ASSIST NEEDY CHILDREN OF EXTRAORDINARY TALENT, REGARDLESS OF THEIR PHYSICAL OR ECONOMIC CIRCUMSTANCES WITH PARTICULAR EMPHASIS ON THE USE OF MUSIC.

THIRD: Article VIII is added as follows:

"Upon the dissolution and winding up of the organization (Corporation), after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to Mystery Park Art Company, Inc.. However, if the named recipient is not then in existence or no longer a qualified distributor, or unwilling or unable to accept the distribution, then the assets of this organization shall be distributed to a nonprofit fund, foundation, association, or corporation organized and operated exclusively for the purposes specified in section 501(c)(3) of the Internal Revenue Code of 1986 and which has established its tax-exempt status under that section or corresponding section of any future federal tax code; or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed off by a Court of Competent Jurisdiction of the County in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine."


