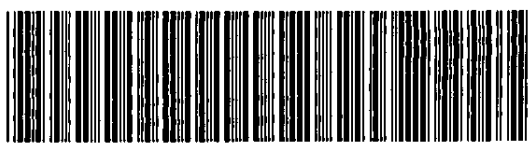

1. ARTICLE III, PURPOSE IS HEREBY AMENDED BY DELETING IT IN ITS ENTIRETY AND SUBSTITUTING THEREFORE THE FOLLOWING:

ARTICLE III. PURPOSE

This corporation is organized exclusively for the purpose of engaging in educational activities within the meaning of Section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future Internal Revenue Code, and more specifically in Jewish educational activities.

2. A NEW ARTICLE VI IS ADDED TO READ AS FOLLOWS:

ARTICLE VI. DISSOLUTION

Should the corporation be dissolved or otherwise permanently cease operations, all real and personal property of any kind, including cash and financial instruments, shall be distributed to another corporation or organization organized exclusively for purposes which are religious, charitable, literary or educational within the meaning of the laws of the State of Florida and Section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future Internal Revenue Code.
