FOR
COMMUNITY HOUSE OF PRAYER
Church of God in Christ, Inc.**

ARTICLE I

Name

The name of this corporation is Community House of Prayer Church of God In Christ Inc.

ARTICLE II

Location

The principle place of business of this corporation shall be 8620 Pensacola Boulevard, Pensacola, Florida. 32534. The mailing address of Community House of Prayer Church of God In Christ Inc. is P.O. Box 18509, Pensacola, FL 32523

ARTICLE III

Purpose

- I. Purpose for which this corporation is organized, and the objectives in which it shall fulfill are as follow:

- A. Major Purpose

Corporation is organized exclusively for charitable and religious purposes, within the scope of section 501 (c) (3) of the Internal Revenue Code.

- B. Specific Purposes: Subject to the major purpose in Section A of Article III,

the corporation shall have the following specific purposes:

1. To preach the gospel of Jesus Christ, and His sacred Word.
 2. To safeguard and advance the spiritual welfare of its members through worship, witness, education, and ministry
 3. To minister to its sick, and to assist in care for its needs.
 4. To seek the salvation of those who know not Christ, and to minister to the spiritual welfare of the community
 5. To proclaim the gospel to the whole world, and applying Christian principles to man and society that God's purposes may be achieved.
 6. To train and ordain to the Gospel ministry those who are called of God, deemed to be qualified for the ministry, and sound in the faith.
 7. To govern itself according to these Articles of Incorporation, and the By Laws adopted for the government of this corporation.

- II. Other purposes for which this corporation is organized are to receive and maintain real or personal property, or both, and subject to the restriction an limitation hereinafter set forth, to use and apply the whole or any part of the income there from and the principal thereof exclusively for charitable, religious, literary, or educational purposes either directly or by contributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code and regulation issued as of now or as is if code is later amended.

ARTICLE IV

Class of Members

This Corporation shall have only one class of members and each shall have one vote on certain issues concerning the Church's policies, procedures and events. The present membership of the Corporation shall consist of the Trustees and the other persons who, at the time of incorporation, are members of Community House of Prayer of Church of God In Christ, Inc. and other members shall be recognized as according to the By-laws of the Corporation.

ARTICLE V

Trustees: Manner of Elections

The Board of Trustees shall consist of five (5) Trustees as determined by the by-laws. Trustees shall be appointed by in the manner set forth in the by-laws. Trustees may be removed and the vacancies shall be filled in the manner provided by the by-laws. The Trustees/Trustee shall have the authority to manage the Business side of the Corporation as set forth in the by-laws.

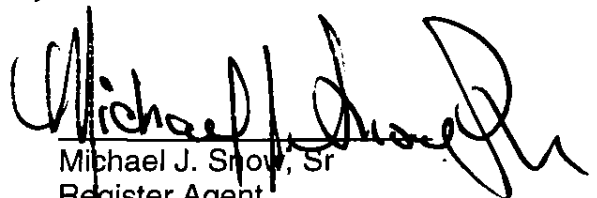

ARTICLE IX

No benefit to Private Persons

No part of the net earnings of this corporation shall benefit, or be distributed to any director or officer of this corporation or any member of this corporation or any other private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes). No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the internal Revenue Code or the corresponding provision of any future Internal Revenue Code or: (b) by a corporation, contributions corresponding provisions of any future U.S. Internal Revenue laws.

ARTICLE X

Term & Dissolution

The date of commencement of corporate existence shall be when these articles have been filed and approved by the Secretary of the state Florida. The term for which the corporation is to exist shall be perpetual.

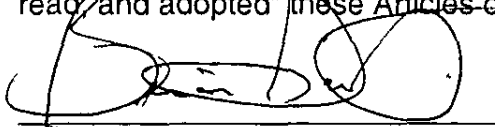
Upon the dissolution of the Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this Corporation shall be distributed for one or more exempt purposes within the realm of Section 501(c)(3) of the Internal Revenue Code. Or shall be distributed to the designated successors exclusively for the purpose of the Corporation in which it was organized, or to such organization (s) organized and operated exclusively for Charitable, Educational, Religious purposes as shall qualify as and exempt Corporation under Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE XI

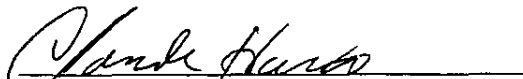
By-Laws
