ATICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE ONE

NAME OF ORGANIZATION

His Kingdom Reign Ministries International, Inc.

ARTICLE TWO

PRINCIPAL OFFICE

The principal office of the organization shall be in the County of Flagler, 129 Pine Grove Drive Palm Coast, Florida 32164 The mailing address: P.O. Box 1934 Bunnell Florida, 32110.

ARTICLE THREE

STATEMENT OF PURPOSES

This corporation has been organized for the purpose of being a church, being operated exclusively for religious spiritual purposes within the meaning of Section 501(C) (3) of the Internal Revenue Code of 1954, as amended, or any superceding section, in order to:

- 1. Minister the Word of God;
- 2. Conduct regular religious/spiritual worship services through various ministers;
- 3. Promote and encourage, through the ministries of the organization, cooperation with other organizations ministering within the community.
- 4. Spread the Word of God: the Gospel of Jesus Christ and the Kingdom of God /Heaven; by ministering to the Church and the world through seminars, internet, radio, television, and other forms of mass media.

- 5. To conduct a local and international church by the direction of the Lord Jesus Christ and under the leadership of the Holy Spirit in accordance with all provisions as set forth in the Holy Bible.
- 6. To maintain local and missionary church facilities.
- 7. To conduct schools for the training of ministers.
- 8. to license and ordain qualified individuals, including graduates of the ministerial school.
- 9. To provide Children's Church or any other type of school for the religious/ spiritual and educational instruction of the young, as well as for adults under the direction of the Church.

This church is not organized, nor shall it operate, for pecuniary gain or profit, and it does not contemplate the distribution of gains, profits, or dividends to its members and is organized solely for non-profit purposes. The property, assets, profits and net income of this church is irrevocably dedicated to charitable, educational and religious/spiritual purposes and no part of the profits or net income of this church shall ever inure to the benefit of any shareholder or individual. On the dissolution or winding up of this church, its assets remaining after payment, or provision of payment of, all debts and liabilities of this church, shall be distributed to a non-profit fund, foundation or corporation that is organized and operated for charitable, educational, ecclesiastical, religious/spiritual, or sacerdotal purposes and that has established its tax exempt status under Section 501(C) (3) of the Internal Revenue code.

ARTICLE IV

MANNER OF ELECTIONS Manner in which the directors are elected or appointed

- 1. The affairs of this church, both spiritual and secular, shall be directed by the initial Board of Directors until an executive Board of Directors is established, which shall consist of the initial Board of Directors, Apostle/ Senior Pastor (President), one (1) Elder, and not less than two (2) other members and no more than seven (7) total board members.
- 2. Each member of the Board of Directors does not necessarily have to be a member of, His Kingdom Reign Ministries International Inc., nor do they have to be a resident of the State of Florida, but must be a person with high moral

standards and a member of the Body of Christ in good standing with their local church body or ministry. Once set in office, each member of said board shall serve their term unless sooner removed as set forth below. The term shall be a limit of one year. A person may become member of the Board of Directors by being nominated by a member of the Board of Directors and must be confirmed by two - thirds (2/3) majority vote of the said Board of Directors.

3. The initial Board of Directors shall be deemed to have been set in office as of the time the Certificate of Amendment of Articles of Incorporation were approved and filed with the Secretary of State, State of Florida. Thereafter, in the event of a vacancy on the board of Directors, whether caused by resignation, removal, death, or expansion of the Board. Vacancies only occur when the members of the Board drop below the minimum number of three (3).
