## ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF OPEN ARMS OF FORT PIERCE, INC.

By these Articles of Amendment, Open Arms of Fort Pierce, Inc. ("Corporation"), amends its Articles of Incorporation pursuant to the provisions of Chapter 607, Florida Statutes, and states:
