ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION OF
BETHANY CHRISTIAN SCHOOL FOUNDATION, INC.

Pursuant to Section 617.1006, Fla. Stat., Bethany Christian School Foundation, Inc., a Florida not-for-profit corporation (the "Foundation"), hereby adopts these Articles of Amendment for the purpose of amending its Articles of Incorporation.

1. The name of the Foundation is Bethany Christian School Foundation, Inc.

2. The following amendment to the Articles of Incorporation of the Foundation was unanimously approved by written consent of the directors of the Foundation as of the 5th day of January, 2011 in the manner prescribed by law under Sections 617.1002(1)(b) and 617.1006(4), Fla. Stat. The

Foundation does not have any members. Accordingly, there are no members entitled to vote on this

amendment.

3. Article III of the Articles of Incorporation of the Corporation is hereby amended to add to

the end thereof, the following paragraph:

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

These Articles of Amendment will become effective on the filing date hereof.
