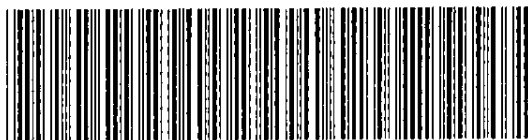

BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation Not For Profit under Florida law.

1. NAME. The name of this Not for Profit Corporation is Downtown Instrumental Boosters, Corp..




