Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: Our great friend was injured in an accident and broke her neck and will require long hospitalization and then rehabilitation and we would like to solicit donations for her expenses.
