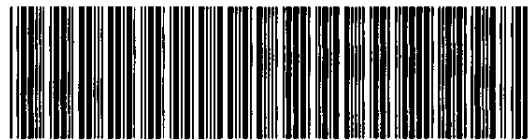

ARTICLES OF INCORPORATION  
OF

**Fondation des Ressources Economiques, Sociales & Culturelles Haïtiennes Inc.**

We, the undersigned, hereby associate ourselves for the purpose of becoming a non-profit corporation under the laws of the State of Florida ; therefore bound by State Statutes regulating information, liability, rights, privileges and immunities of a non-profit corporation.

ARTICCLE I

**Name of corporation**

The name of this corporation shall be:

**Fondation des Ressources Economiques, Sociales & Culturelles Haïtiennes Inc.**

ARTICLE II

**Principal of office**

The initial place of incorporation is 1224 South Dixie Hwy. Lake Worth, Fl 33460. The Mailing address is the same. The Board of Directors may from time to time move the principal place to any other address in Florida and establish branch offices at any other place within or out the State of Florida.

ARTICLE III

**Effective Date**

These Articles of foundation shall be effective upon approval by secretary of State, State of Florida.

ARTICLE IV

**Corporate existence**

This corporation shall exist for a perpetual period of time. It shall have offices throughout and outside the Florida.

## ARTICLE V

### **Purpose**

The purpose for which corporation is organized to exclusively for charitable, religious, educational, literacy and scientific purposes under section 501 (c) (3) of the internal revenue code, or corresponding section of any future tax code.

The specific purpose of the foundation to be transacted by said corporation shall be as follows:

The foster, support and engage in activities relative to humanitarian relief, socio-economic development, progress and ideals, including any and all activities, which are lawful and appropriate in accordance with the laws of the state of Florida. The Organization shall engage in activities and programs that serve the Haitian communities in the United States and Haiti, and which serve to promote socio-economic, cultural and human development, mutual understanding, and public service in both countries.

That of engaging in any activity permitted under the laws of United States of America, its territories, districts, and possessions, and any activities permitted under the laws of the State of Florida, and to have, exercise, and enjoy the powers and privileges granted to corporations not for profit by Chapter 617, Florida Statutes.

To do all and everything necessary, suitable, and proper for the accomplishment of any of the purposes, of the attainment of any objects, or for the furtherance of the powers herein set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act or acts, thing or things, incidental, or appurtenant to or growing out of or connected with the same be not inconsistent with the laws under which this corporation is organized.

## ARTICLE VI

### **Prohibited Activities**

No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purposes set forth herein.

No substantial part of the activities of the corporation shall be the carrying of propaganda, and the incorporation shall not participate in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public offices. Notwithstanding any other provision of theses articles. This corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of its purposes.

ARTICLE VII  
**Capital Stock**

This Incorporation shall have no capital stock and shall be composed of members rather than shareholders.

The incorporation is organized and shall be operated on a nonstick basis within the meaning of the Florida uniform non-profit Corporation Act, and shall not have the power to issue shares of any type or class of stock or other certificates or writings evidencing an ownership of proprietary interest in the corporation.

ARTICLE VIII  
**By-laws (Voting & term)**

By-laws of the corporation are to be made, offered, and rescinded by a majority of qualified members of the organization, present and voting at a regular or special business meeting.

Members shall qualify for admission, and shall be admitted as members, in accordance with the laws of this incorporation. A Two-third vote of the membership shall required for the election of new directors or for the removal of current directors. Annually, during the month of December, the membership shall elect, from among those nominees previously approved by the EXECUTIVE COMMITTEE of the board, those members receiving the highest number of votes as there are vacancies. Each elected director shall a serve a term of office for a period of four (4) years. Any elected director may be re-elected for an additional three (3) years term.

ARTICLE IX  
**Initial board of directors**

Initially, this corporation shall have seven (7) directors. The number of directors may increase or decrease depending on organization needs, but may never be less than three (3). The directors shall hold office for the first four (4) years of existence of the corporation and until their successors are elected or appointed according to the by-laws.

Dissolution

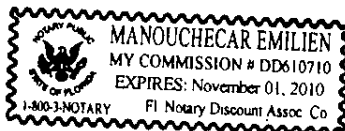

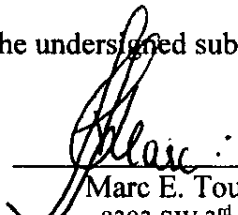
ARTICLE XII
