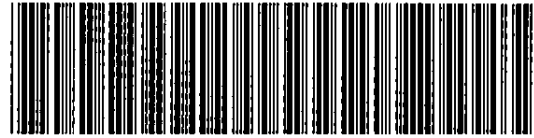

The name of the corporation shall be: Academy of Martial Arts Community Outreach, Inc.

Article II - Principal Office

The principal place of business of this corporation shall be: 333 West Granada Blvd. Suite 240, Ormond Beach, FL 32174

Article III - Purpose

The purpose for which the corporation is organized is: to make martial arts training available to people who otherwise could not financially afford it, and to utilize martial arts principles and training for individual self-improvement and the benefit of the community. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
