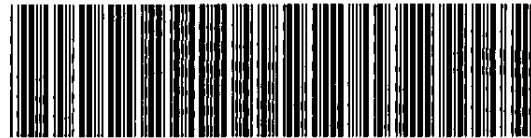

ARTICLES OF INCORPORATION
In compliance with Chapter 617, F.S.,
(Not for Profit)

ARTICLE I

Name.

The name of the corporation shall be Start With ONE, Inc.

ARTICLE II

Principal Office.

The principal place of business and mailing address of the corporation shall be:
254 SW Bridgeport Drive
Port Saint Lucie, FL 34953

ARTICLE III

Purpose.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The purposes for which the corporation is organized are:

1. To explore and address the root causes of pressing problems affecting communities around the world. This corporation is committed to the betterment of people in less fortunate countries through the institution of education. In order to effectuate this general purpose, Start With ONE, Inc. is fully committed to working alongside worldwide communities to create and implement viable solutions to improve education, health, and the environment.
2. To aid, support, and assist by contributions, or otherwise, other corporations, community chests, funds and foundations organized and operated exclusively for charitable or educational purposes.
3. To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either

directly or indirectly, and either alone or in conjunction or cooperation with others.
4. All of the foregoing purposes shall be exercised exclusively as charitable and educational purposes in such a manner that the corporation will qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IV

Manner of Election.

As stated in the bylaws, directors shall be elected by the members at the annual meeting of the corporation.

ARTICLE VIII

501(c)(3) Limitations.

1. No Private Inurement:

The corporation is not organized nor shall it be operated for the primary purpose of generating pecuniary gain or profit. The property of this corporation is irrevocably dedicated to a charitable purpose and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual, except as reasonable compensation for services actually performed in carrying out the corporation's charitable and educational purposes.

2. Lobbying and Political Campaigns:

No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on by any organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

3. Dissolution:

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IX

Effective Date.

These Articles of Incorporation shall be effective on and after October 10, 2010.

Having been named as a registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
