ARTICLES OF AMENDMENT

EASTERN HILLSBOROUGH COMMUNITY BAND, Inc. (A Florida Not for Profit Corporation)

SALLARES AND SALLO Pursuant to the provisions of section 617.1002 and 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

MANNER OF ADOPTION:

The amendment(s) was (were) adopted by the members and the number of votes cast for the amendment was sufficient for approval.

These Articles of Amendment were adopted by the board of directors of said organization at a regular meeting with a quorum being present which was held on May 10, 2011. This meeting of the directors met the requirements of both the Articles of Incorporation and the bylaws.

THE AMENDMENTS

The Articles of Incorporation of the EASTERN HILLSBOROUGH COMMUNITY BAND, Then, are hereby amended as follows:

Article III of the Articles of Incorporation is hereby replaced. The new Article III reads as follows:

> Article III Purpose

The purpose for which the corporation is organized is:

EHCB is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Article X of the Articles of Incorporation is hereby replaced. The new Article III reads as follows:

> Article X Distribution of Assets Upon Dissolution of Corporation

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the

Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purpose or to such organization or organizations, as said Court shall determine, which are organized or operated exclusively for such purposes.
