# ARTICLES OF INCORPORATION

In compliance with Chapter 617.0202 F.S. (Not for Profit)

#### Article I Name

The name of this corporation shall be Majele, Incorporated.

# Article II Registered Office Address

The principal place of business is 4420 Shannon Lakes West, Tallahassee, Florida 32309.

# Article III Purpose

This corporation is organized exclusively for combating community deterioration, charitable and educational purposes as specific in Section 501 (c) (3) of the Internal Revenue Code, including for such purposes, the making of distributions to organizations under Section 501 (c) (3) of the Internal Revenue Code

# The purpose of this corporation is:

- . to prevent community deterioration
- . to enhance health and wellness
- . to support and enhance better business enterprise

# Article IV Manner Directors are Appointed Exemption Requirements

At all times the following shall operate as conditions restricting the operations and activities of the corporation:

1. No part of the net earnings of the organization shall inure in the benefit of, or be distributable to its members, trustees, officers or other private persons, except that organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause thereof.



- 2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
- 3. Notwithstanding any other provisions of this document, the organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or by an organization, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or corresponding section of any future tax code.

The Directors will be appointed. This corporation will not have members. The management of the corporation shall be vested in a board of directors as defined by the corporation's bylaws.

No director shall have any right, title, or interest in or to any property of the corporation.

The number of directors constituting the initial board of directors is three(3).

Members of the initial board of directors shall serve until the first annual meeting, at which their successors will be duly appointed, or removed as provided in the bylaws.
