ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF JEWISH BURIAL SOCIETY OF PINELLAS COUNTY, INC.

Pursuant to Section 617.1006 of the Florida Statutes, Jewish Burial Society of Pinellas County, Inc., a Florida not for profit corporation (the "Corporation"), adopts the following amendment to its Articles of Incorporation:

 Article 6 shall be deleted in its entirety and replaced in its entirety with the following:

"Article 6"

The affairs of the Corporation shall be managed by a Board of Directors consisting of no fewer than three (3) individuals. The members of the Board of Directors shall be appointed in the manner described herein and in the Corporation's Bylaws. Congregation B'nai Israel of St. Petersburg, Inc. and Temple Beth-El of St. Petersburg, Florida, Incorporated shall appoint a majority of the directors serving on the Board of Directors at any given time. The Corporation shall initially have six (6) directors; provided, however, that the Board of Directors may, by a majority vote, increase or decrease (to no fewer than three (3)), the total number of members on the Board of Directors.

The effective date of this Amendment shall be the date that they are filed with the Secretary of State.

The Corporation does not have any Members. This Amendment was adopted by the Board of Directors, effective November 9, 2022.
