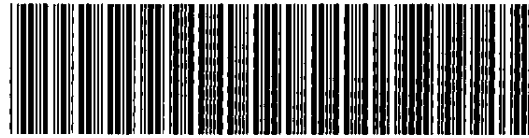

ARTICLE I - NAME

The name of the corporation is Ready 2 Give, Inc. This corporation is incorporated under the laws of the State of Florida as a non-profit corporation.

ARTICLE II- PRINCIPAL OFFICE

ARTICLE III - PURPOSE

The organization is organized exclusively for charitable, religious, educational, and/or scientific purposes under Internal Revenue Code section 501(c)(3) or corresponding section of any future federal tax code. Upon the dissolution of this organization, assets will be distributed for one or more exempt purposes within the meaning of Internal Revenue Code section 501(c)(3), or corresponding section of any future federal tax code, or will be distributed to the federal government, or to a state or local government for a public purpose.
