Article I.

Name

Section 1.01

The name of the Corporation is THIS IZ MY STORY PRODUCTIONS, INC.

Article II.

Principal Office and Address

Section 2.01 The address of the principal office of the corporation is 10524 Moss Park Road Ste 204-148, Orlando, FL 32832.

Article III.

Duration

Section 3.01 The term of existence of the Corporation is perpetual; and the corporate existence will commence on the filing of these articles by the Department of State.

Article IV.

Purpose

Section 4.01 The This Iz My Story Productions, Inc. nonprofit corporation formed under Florida Statutes §617 is organized and shall be operated in accordance with the meaning and provisions of Section 501(c)(3) of the Internal Revenue Code and the regulations issued thereunder.

Section 4.02 Primarily the purposes for which the Corporation is organized are: ministry, religious education, religious education through documentary film and other entertainment media source outlets, missionary activities, and expanding Christianity through the conversion of new members and humanitarian work aiding the poor, victimized and disadvantages.

Section 4.03 Generally to have and exercise all rights and powers conferred on nonprofit corporations under the laws of Florida, or which may hereafter be conferred, including the power to contract, rent, buy, or sell personal or real property; provided, however, that this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.

Section 4.04 Notwithstanding any of the above statements of purposes and powers, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.

Article V. Directors

Section 5.01 The Board of Directors shall have the general power to manage and control the affairs and property of This Iz My Story Productions, Inc., and shall have full power, by majority vote, to adopt rules and regulations governing the action of the Board of Directors.

Section 5.02 The board of directors shall consist of no less than 3 (three) directors in accordance with Florida Statute §617.0803.

Section 5.03 Directors need not be residents of the State of Florida. Election to the Board of Directors shall be by majority vote of the members of the Corporation, which shall occur, except in the case of

filling vacancies, at each annual meeting thereof. Each Director shall hold office for a term of 2 (two) years and thereafter until his successor is elected and qualified.

The method of election of the directors of the Corporation may be amended from time to time as set forth in the bylaws.
