

ARTICLES OF INCORPORATION FOR

HILLSBOROUGH COUNTY ELEMENTARY PRINCIPALS'

I. NAME

The name of the corporation is HILLSBOROUGH COUNTY ELEMENTARY PRINCIPALS' COUNCIL, INC.

II. PRINCIPAL OFFICE
