AMENDED ARTICLES OF INCORPORATION OF MUNREE CEMETERY, INC.

ARTICLE I

Be it known and it is so declared that the name of the corporation is: MUNREE CEMETERY, INC.

ARTICLE II

The objectives and purposes for which this corporation are organized, and the manner of the business to be carried on by it are as follows:

- 1. To identify, inventory and develop the Munree Cemetery as historically significant African American Cemetery.
- 2. To restore and develop the Munree Cemetery as a burial ground for future individuals and families in the Leon County, Florida community.
- 3. To receive donations, gifts, bequests and other special advantages to and for the fulfillment of the objectives and purposes of the corporation.

The foregoing enumeration of powers is not a limitation or restriction in any manner on other powers, privileges and authority conferred upon this corporation by the U. S. Constitution, the laws of the State of Florida and the Internal Revenue Code.

ARTICEL III

The duration of this corporation is declared to be perpetual.

ARTICLE IV

Declare and be it known that this is a not for profit corporation organized on a no stock/share basis; organized exclusively for charitable, educational or religious purposes within the meaning of section 501(c) (3) of the Internal Revenue Code of 1986 or any corresponding section of any future federal tax code.

ARTICLE V

ARTICLE VI

The Board of Directors of this Corporation is comprised of no less than one (1) person. The total number of Directors shall be determined by the Board. The total number shall be an odd number and never an even number. The initial incorporator and director is:

ARTICLE VII

This corporation shall not discriminate against students or student participation, regardless of race, ethnicity, color, national origin or student status.

ARTICLE VIII

Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government for a public purpose.

ARTICLE IX

A member, officer or director of this corporation is not liable for any contracts, debts, or defaults of this corporation without that person's express written consent.

ARTICLE X

The initial board of directors, at its first meeting or at some other time, shall appoint an Advisory Board. The number of members shall be determined by the Board of Directors, but in all cases the total members shall be an odd number and in no event an even number. No member of the Advisory Board shall be a member of the Board of Directors; unless so appointed by majority vote of the Board of Directors.

The role of the Advisory Board is to provide information and advice to the Board of Directors; in furtherance of the purposes, goals and objectives of this corporation.
