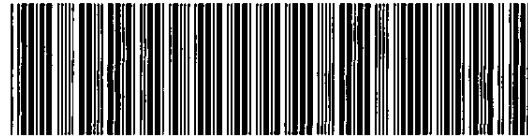

FOR

*The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:*

- I. CORPORATION NAME - The name of the Corporation shall be **VETERANS RESOURCE CENTER OF AMERICA, INC.**
- II. PRINCIPAL OFFICE - **VETERANS RESOURCE CENTER OF AMERICA, INC.** shall have its principal office(s) at 353 Jackson Street Dunedin, Pinellas County, Florida.

PURPOSE - The specific purposes for which **VETERANS RESOURCE CENTER OF AMERICA, INC.** is organized are exclusively charitable, educational, cultural, scientific, literary and faith-based within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. Additionally, **VETERANS RESOURCE CENTER OF AMERICA, INC.** will provide assistance to American Veterans (Active) and (In-Active) who need assistance in solving many of their problems. Furthermore, this organization will also serve as a liaison to provide one on one counseling and economic improvement to all participants of **VETERANS RESOURCE CENTER OF AMERICA, INC.** Finally, the **VETERANS RESOURCE CENTER OF AMERICA, INC.** will partner with others to assure the overall well being of all America Veterans.

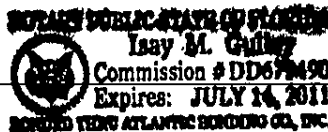
