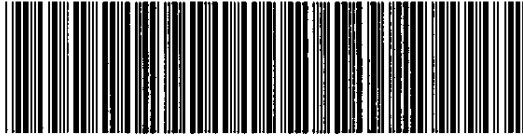



The undersigned, acting as incorporator of a corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

Article I. Corporate Name: The name of the corporation is Michelle's Kids, Inc.

Article II. Corporate Addresses: The principal office of the corporation is located at 8419 Millwood Dr, Tampa, FL, 33615. The mailing address of the corporation is 8419 Millwood Dr, Tampa, FL, 33615.

Article III. Purpose: The specific purpose for which this corporation is organized are exclusively charitable, educational and scientific and consist of the following:

1. This corporation is formed exclusively for charitable and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law."
2. To aid, support, and assist by gifts, contributions, or otherwise, other corporations, community chests, funds and foundations organized and operated exclusively for charitable or educational purposes, no part of the net earnings of which inures to the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation.
3. To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, association, trusts, institution, foundations, or governmental bureaus, departments or agencies.
4. All of the foregoing purposes shall be exercised exclusively charitable and educational purposes in such a manner that Michelle's Kids, Inc. will qualify as an exempt organization under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Article IV. Directors: The manner in which Directors are elected or appointed is: AS PROVIDED FOR IN THE BYLAWS.

Article VIII. The Effective Date of Corporation shall Be: November 3, 2010.

Article IX. Membership: The qualification and duration for members, if any, and the manner of their admission shall be regulated by the bylaws

Article X. 501(c)(3) LIMITATIONS

1. **CORPORATE PURPOSES:** Notwithstanding any other provision of these 7 articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal and state income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
2. **EXCLUSIVITY:** Michelle's Kids, Inc. is organized exclusively for charitable and educational purposes.
3. **NO PRIVATE INUREMENT:** Michelle's Kids, Inc. is not organized nor shall it be operated for the primary purpose of generating pecuniary gain or profit. Michelle's Kids, Inc. shall not distribute any gains, profits or dividends to the Directors, Officers, or Members thereof, or to any individual, except as reasonable compensation for services actually performed in carrying out Michelle's Kids, Inc.'s charitable and educational purposes. The property, assets, profits and net income of Michelle's Kids, Inc. are irrevocably dedicated to charitable and educational purposes no part of which shall inure to the benefit of any individual.
4. **LOBBYING AND POLITICAL CAMPAIGNS:** No substantial part of the activities of Michelle's Kids, Inc. shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and Michelle's Kids, Inc. shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.
5. **DISSOLUTION:** Upon winding up and dissolution of Michelle's Kids, Inc., the assets of Michelle's Kids, Inc. remaining after payment of all debts and liabilities shall be distributed to an organization recognized as exempt under section 501(c)(3) of the Internal Revenue Code of 1986 to be used exclusively for charitable and educational purposes. If Michelle's Kids, Inc. holds any assets in trust, such assets shall be disposed of in such a manner as may be directed by decree of the Circuit Court of the district in which Michelle's Kids, Inc.'s principal office is located, upon petition thereof by the Attorney General or by any person concerned in the liquidation.

6. **"PRIVATE FOUNDATION" PROVISIONS:** In the event this Corporation is considered to be a "Private Foundation" by the U.S. Internal Revenue Service under provisions of the United States Code the following provisions apply:
- A. Michelle's Kids, Inc. will distribute its income for each tax year at a time and in a manner as not to become subject to the tax on undistributed income imposed by section 4942 of the Internal Revenue Code, or the corresponding section of any future federal tax code.
 - B. Michelle's Kids, Inc. will not engage in any act of self-dealing as defined in section 4941(d) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
 - C. Michelle's Kids, Inc. will not retain any excess business holdings as defined in section 4943(c) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
 - D. Michelle's Kids, Inc. will not make any investments in a manner as to subject it to tax under section 4944 of the Internal Revenue Code, or the corresponding section of any future federal tax code.
 - E. Michelle's Kids, Inc. will not make any taxable expenditures as defined in section 4945(d) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


Article XI. Membership: The qualification and duration for members, if any, and the manner of their admission shall be regulated by the bylaws

INDEMNIFICATION - Any person (and the heirs, executors and administrators of such person) made or threatened to be made a party to any action, suit or proceeding by reason of the fact that he is or was a Director or Officer of Michelle's Kids, Inc. shall be indemnified by Michelle's Kids, Inc. against any and all liability and the reasonable expenses, including attorney's fees and disbursements, incurred by him (or by his heirs, executors or administrators) in connection with the defense or settlement of such action, suit or proceeding, or in connection with any appearance therein, except in relation to matters as to which it shall be adjudged in such action, suit or proceeding that such Director or Officer is liable for negligence or misconduct in the performance of his duties.
