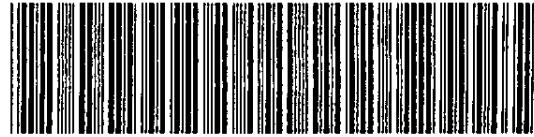

## **Amendments**

### **Purpose**

#### **Article III**

**The purpose for which the corporation is organized is exclusively for charitable, religious, educational and scientific purposes under section 501(c)(3) of the Internal Revenue Code or corresponding section of any federal tax code. Specifically, for the purpose of providing children, youth, and teens, mentoring, tutoring, educational stability, social and life skills. In addition to exposure and opportunities in the arts, students will acquire various skills for daily living and problem solving.**

#### **Article DISSOLUTION**

**Upon the dissolution of the corporation, assets shall be distributed exclusively for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code that has the same purpose of The Village Involvement Program, Inc. that provides mentoring, tutoring, educational stability, social and life skills for children, youth and teens to include cultural arts. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court determined which are organized and operated exclusively for such purposes.**
