

(A Florida Not-For-Profit Corporation)

ARTICLE I. NAME

The name of this corporation shall be BLACK DIAMOND MEMBERS' ADVISORY COMMITTEE, INC., with its principal office address being located at 3319 N. Spyglass Village Path, Lecanto, Florida 34461.

This corporation shall have perpetual existence.
