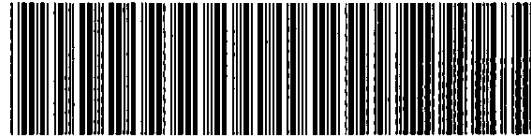

Said organization (Cord Ministries, Inc.) is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future tax code.

ARTICLE IX: Upon dissolution of Cord Ministries, Inc., any remaining assets will be distributed to First Baptist Church, 301 Avenue G, Del Rio, Texas, 78840, with the designation that those funds be used for mission work or mission activities. First Baptist Church, Del Rio, Texas, is a 501 (c) (3) organization. Upon the dissolution of the organization (Cord Ministries, Inc.), assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed by the Court of Common
