The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

Article I: The name of the Corporation shall be **tvm Christian University Corp.**

Article II: The place in this state where the principal office of the Corporation is to be located at 4364 W 35th Street Orlando, FL 32835 of Orange County.

Article III: Purpose
