ARTICLES OF INCORPORATION

ARTICLE I:

Happy Horse Rescue Ranch, Inc.

ARTICLE II:

Place of Business: 11075 SE Hwy 42 Summerfield, Florida 34491

ARTICLE III:

The purpose of this not for profit organization is to rescue abused and abandoned horses. The ranch will feed, groom, provide medical care and rehabilitation of the horses on a day to day basis. All these activities cost money so our approach is to sell these horses or adopt them for a fee once they are ready and healthy enough to leave the ranch. The abuse to some of these animals is so great that the above care could take months even over a year prior to them being ready for adoption or sale. Some of these animals will have to be retrained so that the new owner will be able to ride and enjoy the horse once they take ownership. Some of these animals will be either so old or so badly injured in mind or body that they would not make a suitable animal for adoption or sale. These animals would stay at the ranch for the remainder of their lives. We also plan to have people donate money toward the care of a specific animal that they would chose by a picture or description of the horse.

With the help of financial support from the community we will be able to provide these services to all horses referred to us or brought to us or rescued from abusive individuals.

The need is so great in this area of central Florida as this is horse country in Florida. Some of our animals come from people who can no longer afford to keep them which results in abandonment and with the shape of the economy this need is getting greater.

The directors will be elected in a general vote of the board at the December board meeting and will then take office in January of the new year.
