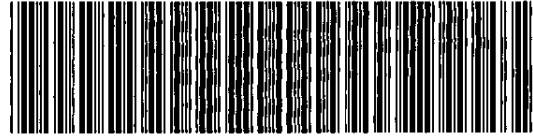

The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes, religious, and educational purposes. the making of distributions to organizations that qualify as exempt organizations under section 501 (C) 3 of the internal Revenue Code. The programs will consist of, but shall not be limited to: Child Care, Job Training, Job Placement, disable persons services, Housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Substance Abuse Awareness and Prevention, Tutoring, AIDS, Elderly Care and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, stock and shall have other members.



Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
